THEREAFTER, MONTHLY TRANSIENT DOCKAGE IS PAYABLE IN ADVANCE FOR EACH CALENDAR MONTH AND IS NOT SUBJECT TO PRORATION EXCEPT AS EXPRESSLY PROVIDED IN THE CAPE MARINA SLIP/STORAGE LICENSE AGREEMENT. THE MARINA MAY TERMINATE DOCKAGE EARLY ON 72 HOURS' NOTICE; ANY UNUSED PREPAID DAYS ARE REFUNDED PER DIEM. SEE THE SLIP/STORAGE LICENSE TERMS.

ALL SLIPS ARE SUBJECT TO A MINIMUM BILLABLE LENGTH. ANY EXCEPTION TO THE SLIP SIZING REQUIREMENT MUST RECEIVE PRIOR APPROVAL FROM THE DOCKMASTER.
